# 22/010 Apologies

# 22/012 Public Participation

A resident raised the issue about speed in the village, particularly from tractors which are travelling at an excess speed. Councillors agreed that this is an issue. Cllr Moores gave the resident information regarding the feedback that had been received from Highways previously as they had declined other speed measures on that stretch of road. It was agreed that the Clerk will circulate the speed concern link to councillors and the 20's Plenty Campaign and put this on the website. Cllr Bardon raised the possibility of using volunteers for a speed test programme, the Clerk will look into this further.

A resident advised that they had been successful in securing some trees for the village, which will be available in November for planting.
